# TOURNAMENT RULES

1. **RULES**

The Following rules for the tournament will be used. These rules will be interpreted solely by the tournament committee and all are final. St. Louis Bass Busters has the right to refuse any entries.

2. **ENTRY FEE**

\$110.00 per Boat. Big Bass included. Early entries must be post marked no later than March 22, 2010. **Entries will be accepted at the ramp the day of the tournament (CASH ONLY). \$10.00 LATE FEE.**

3. **ELIGIBILITY**

A. All individuals 18 years of age or older with paid entry fee. Fishing Partner does not have to be 18 years of age.

4. **SAFETY & SPORTSMANSHIP**

Sportsmanlike conduct and safe boating must be observed at all times. Life jackets and kill switches must be worn any time the big motor is above an idle.

5. **FISHING LOCATIONS**

Any where on Lake of the Ozarks except inside the buoys of both P.B. 2 ramps. NO TRAILERING of boats.

6. **TACKLE & EQUIPMENT**

Only artificial bait or lures may be used, Pork style baits are allowed. No trolling. Rod and Reel only.

7. **SCORING**

Largemouth, Spotted, and Smallmouth Bass will be counted. Total stringer weight per team will determine place. Any bass under fifteen (15) inches presented for weigh-in will cause two (2) pounds to be subtracted from the total stringer plus the loss of the short fish. Five (5) Fish per boat may be weighed -in. Any frozen or iced fish presented for weigh-in will result in immediate disqualification. A .50 penalty per dead fish will deducted from total weight. No culling in weight area.

8. **POLYGRAPH TEST**

Polygraph test may be given to 1st place, 2nd place, and big fish and at random at the discretion of the tournament committee.

9. **PROTEST**

All protest must be submitted in writing and signed with-in 15 minutes after total weigh-in completion.

10. **LATE PENALTY**

Any Boat checking in late will be disqualified.

11. **TIES**

All ties for the total weight will be broken by the earliest boat position. In the case of a tie for Big Bass, the cash prize will be equally divided between the two contestants.

12. **NO REFUNDS**

Unless cancellation by the Tournament Committee.
